Texas PRIMA's Education Session Highlights



The Proof is in the Data: Applying Predictive Analytics to Reduce Workers' Compensation Risk

Presented by Skip Brechtel at the 2017 Texas PRIMA Annual Conference Wouldn't you want to know about a potential risk before it occurs? Predictive analytics could be the answer to alert when risks are ahead. How can you capture the data? Do you know your claim drivers? Do we have the appropriate data fields? Are we mining the data? These are all questions you might ask yourself to determine whether predictive

analytics can be the solution to mitigating risk in your organization. IT has evolved over the years, and more memory means more power. A computer's memory has increased 24,800%. We also have access to faster, bigger, and cheaper storage. In 2001, you may have stored your files on premises, which was a large capital investment. Now, many organizations use the cloud for storage. We have experienced a 733% size increase in storage, a 2248% speed increase, and a 77% cost decrease.

A review of today's workforce can also help in applying predictive analytics. The first major trend to address is co-morbidities. The leading co-morbidity is obesity at 42%, followed by advanced age at 32%, and metabolic disorder at 14%. Co-morbidities influence an injured workers' medical, therapy care, and outcomes. We are also facing an aging workforce. In 1990, only 12% of the U.S. workforce was over the age of 55. In 2020, predictions forecast 25% of the U.S. workforce will be over the age of 55. An aging workforce brings several benefits to an employer, including experience, knowledge, and loyalty. However, an aging workforce may also lead to slower healing rates in addition to co-morbidities.

Now, how does this impact your workers' comp claims? An injured employee between the age of 26-35 has on average 15.9 visits ordered and completes 10.4 of those visits. An injured employee between the age of 56-65 has on average 18.6 visits ordered and completes 12.9 of those visits. The median lost days for an injured worker age 24-34 is six whereas the median lost days for an injured worker over the age of 55 is 12. Usually, an older employee has higher wages, which equates to higher indemnity dollars paid. An injured worker considered to be obese can experience eight times more missed work days, five times higher medical costs, and eight times greater indemnity costs.

According to a Towers Watson survey conducted in 2011, Liberty Mutual Vantage Comp experienced a 5% reduction in workers' comp costs by utilizing predictive analytics. Sedgwick reported average incurred costs decreased 6-8% in 2014. CCMSI reported a 5-10% reduction in costs in 2016. CCMSI developed a Claim Risk Assessment (CRA) tool, which is completed within 10-15 days of receipt of a new indemnity claim. The CRA includes basic background questions, accident/injury information, employer history information, health history/lifestyle information, injury history information, and medical information. The CRA is scored on a red, yellow, green rating system. Red is high risk exposure, yellow is medium/moderate risk, and green is low risk. Carriers can utilize the results of the CRA to determine at an early stage of the claim whether nurse case management, return to work opportunities, or surveillance is necessary.

In closing, predictive analytics can provide exceptional outcomes in controlling costs, minimizing risk of exploding claims, maximum medical recovery, return to work, and claim closure. Using the data we have from investigating the claim can help us make better decisions more accurately, consistently, and timely.
