Take Safety as Your Partner

Because of COVID-19, my life looks different today than it did yesterday. I would imagine almost everyone's life – everyone's world, in fact – is somewhat different than it was just a couple of months ago. No one could have predicted how quickly this pandemic would spread, nor how much it would mirror a rollover car crash in the sense that it has turned almost everything we do upside down.

Crashes happen in a blink of an eye and have many of the same life-altering effects as this virus, not only for the victims, but also their loved ones. As we focus on our health and how we return to work safely, we should also focus on items we once took for granted, such as driving, and view them through a different lens. I think we can agree road safety should move up a level or two in our hierarchy of what's perceived as important.

I tend to view things through a safety lens, whether the task is driving, or something else involving work, or my personal life. What lens do you use? How can you take advantage of these circumstances to build a better tomorrow? Let me suggest you double-down on safer driving choices and work to promote safe driving behaviors during meetings or conversations with friends and co-workers.

We know that total injury costs from crashes drain hundreds of billions of dollars from the U.S. economy annually, including medical expenses, wage and productivity losses. Now more than ever, I see this as a needless waste, and as we try to find our way moving forward, I see an opportunity for change.

Mental distractions are not going away. People are struggling to put food on the table and pay their bills. Their minds are racing. Behind the wheel, that poses a risk. Distracted drivers are dangerous drivers. You can lead by speaking in an empathetic voice and involving employees in decisions that impact their health and wellbeing.

That includes safety – at work, at home and on the roads. While traffic volume has diminished during this pandemic, there has been a nationwide surge in speeding and reckless driving incidents. Evaluation policies and procedures take on greater importance as this is not business as usual, not yet. Slow down. So you can live in this moment and the next.

Driving too fast makes it harder to react in dangerous situations and increases the force of impact during crashes. Buckle up – every person, every seat, every time. It's your best defense in a crash. Talk about risks associated with fatigue and the importance of sleep-health.

Being awake for 18 to 24 hours can have the same effect on your body as alcohol impairment. Adults need seven to nine hours of sleep to reach peak performance levels. A good night's sleep can reduce stress levels, increase memory and lower your blood pressure.

Today, it is more important than ever you are on top of your game, whether working from home, in the office or sitting behind the wheel. Think of safety as a compass leading you on a journey. There is no reason to get lost or to even crack open the door and let more risk seep into your life.
